

**DEPARTMENT OF LICENSES AND INSPECTIONS**  
**REGULATIONS UNDER PHILADELPHIA CODE SECTIONS**  
**GOVERNING FEE INCREASES FOR PERMITS AND LICENSES**  
**(§§ 6-301, 9-102, 4-A-901.15)**

The Department of Licenses and Inspections hereby promulgates the following regulations regarding License and Permit Fee Revisions under Sections 6-301, 9-102, 4-A-901.15 of The Philadelphia Code.

Fees are being increased to an amount equal to or lesser than the fee as it existed on July 1, 2017, multiplied by the CPI Multiplier (26.5%).

This new fee schedule shall take effect on January 1, 2025. It replaces and supersedes the fee schedule promulgated on August 8, 2022, which became law on September 8, 2022, effective January 1, 2023.
