## **Executive Director's Report**

- 1. PAC has adapted to COVID -19 stay at home orders and all staff are working remotely.
- 2. PAC has also had ongoing and open communication with the PPD regarding their policies and practices in response to COVID-19.
- 3. PAC has continued to maintain representation on the illegal eviction action team and monitors the PPD response help evictions brought to us by this group.
- 4. PAC ED presented at Rutgers Law regarding Civilian Oversight and Civil Rights
- 5. PAC ED met with Commissioner Danielle Outlaw.
- 6. PAC met with PPD and the Mayor's Office of Workforce Development to discuss recruitment strategies.
- 7. PAC has been invited to attend racial equity working group convened by the Office of Diversity, Equity and Inclusion.
- 8. PAC has worked with the Philadelphia Police Department (PPD), the Office of Immigrant Affairs(OIA), the Philadelphia Chinatown Development Corporation (PCDC) and the Mayors Commission on Asian American Affairs (MCAAA) to address some gaps in the communication regarding bias incidents.
