- No vendor or person shall load or unload merchandise for a period exceeding twenty minutes.
- No vendor or person shall conduct licensed operations between eleven p.m. and six a.m.
- No vendor or person shall conduct sidewalk sales from a truck or park or maintain any truck in parking spaces adjacent to vendor site, except for brief periods, not to exceed 20 minutes.
 - As necessary to transport sidewalk stands.
 - As necessary for deliveries, provided that deliveries shall take place only in legal parking spaces or designated loading zones.
- No vendor or person shall violate the provisions of the Philadelphia Code.
