# Limits and Conditions

No vendor or person shall stop, stand or park any vehicle, wagon, pushcart or any other conveyance upon any street for the
purpose of selling, or sell on any street under any circumstances during the hours when parking, stopping or standing has
been prohibited by signs or curb markings or is prohibited by City Ordinance or The Philadelphia Code.

- No vendor or person shall stop, stand or park his vehicle or conveyance on a street nor permit it to remain there except on the roadway at the curbs for the purpose of selling goods, ware, and merchandise.
- No vendor or person shall stop, stand, park, place nor allow his conveyance closer than thirty feet from any other conveyances being used by any other vendor.
- No vendor or person shall conduct himself or his business in such a way as would restrict or interfere with the ingress or
  egress of the abutting owner or tenant or to create or become a nuisance, or increase traffic congestion or delay, or
  constitute a hazard to traffic, life or property, or an obstruction to adequate access to fire, police, or sanitation vehicles.
- No vendor or person shall sell foods, drinks, ice cream or confections of any kind for immediate consumption unless he has available for public use his own litter receptacle.
- No vendor or person shall use a handcart or pushcart the dimensions of which exceed four feet in width, eight feet in length and eight feet in height.
- No vendor or person shall use any conveyance, device or thing whatsoever which, when fully loaded with merchandise, cannot be easily moved and maintained under control by the licensee, his employee or attendant.
- No vendor or person shall set up, maintain or permit the use of any tables, crates, cartons, racks, devices or thing of any kind or description to increase the selling or display capacity of his conveyance, cart or vehicle.
- No vendor or person shall sell any merchandise or any other article or thing whatsoever on any street where sidewalk sales are prohibited under any ordinance of this City or City Code provision.
- No vendor or person shall leave any conveyance unattended at any time or store, park, or leave same overnight on any city sidewalk or street or at any vending location, unless the Department approves a Mobile Food Vendor to remain overnight in connection with a special event sponsored by the City.
- No vendor or person shall engage in business of vending between twelve midnight and seven a.m.
- No vendor or person shall sell any merchandise or any other article or thing whatsoever on any property owned or controlled by the City of Philadelphia, except for streets, unless permission has been expressly granted by the City of Philadelphia.
- No vendor or person shall sell any fireworks.
- No mobile food vendor shall operate on a historic site.

#### **Newsstands / Honor Boxes:**

- Not more than one newsstand may be licensed on any corner; two newsstands at any intersection; two newsstands on one side of one block.
- Newsstands and honor boxes shall not be placed on the sidewalk of any street so as to reduce the footway space.
- Attachments, racks, benches, boxes or similar items may not be externally attached to or adjacent to newsstands.
- Honor boxes must be constructed or fastened so as to prevent them from falling over or being moved from their location and
  are to be constructed as to prevent their contents from being scattered or carried by the elements.
- No commercial advertising, exclusive of the name of a newspaper or publication sold or in connection with contents of such newspaper or publications, will be permitted on newsstands and honor boxes.
- Newsstand operators shall not permit the area surrounding their newsstands to become littered as a result of the operation
  of the stands.
