The Planning Commission Chair John Mondlak, called the Commission to order at 1:00 p.m.

Nina Solomonik, of the Philadelphia City Planning Commission, (PCPC) – introduced the Zoom platform and remote City Planning Commission process. We are hosting this meeting on Zoom. We may also have some people join us by phone.

During today's meeting, each agenda item will be presented by a member of the staff. Following each presentation, the Chair will ask the Commissioners for questions or comments. The Chair will then ask the audience for questions and comments. After that, the Commissioners will finish their discussion and vote.

Those of you who are joining us on Zoom will have two options to ask questions and comments. If you would like to speak, click, or tap on the "RAISE HAND" button on the menu bar on the bottom of your screen at any time during the agenda item. You will be called on and will have the opportunity to speak to the Commission and the audience.

If you prefer to type your question or comment, click, or tap on the "Q&A" button on the menu bar at the bottom of your screen at any time during the agenda item. Once all attendees have had an opportunity to speak, I will read out loud any written questions and comments that have been posted to the Q&A.

For those joining by phone, we're unable to take spoken testimony, however, you can email your questions and/or comments to the Commission at Planning@phila.gov. This meeting will be recorded and posted to our website.

Ms. Solomonik turned the meeting over to Chair Mondlak to begin the Planning Commission meeting.

1. Action Item: Bills Nos. 240177 and 240178: Sub Fiscal Year 2024 Capital Budget and Fiscal Year 2024-2029 Capital Program Mid-Year Amendments. Introduced by Councilmember GilmoreRichardson for Council President Johnson on March 14, 2024. (Presented by Greg Waldman).
 - a. Bill No. 240177: Amending Bill No. 230145, entitled “An Ordinance To adopt a Fiscal 2024 Capital Budget,” by revising various appropriation amounts and totals, all under certain terms and conditions.
 - b. Bill No. 240178: Amending Bill No. 230144, entitled “An Ordinance To adopt a Capital Program for the Six Fiscal Years 2024-2029 Inclusive,” by revising various appropriation amounts and totals to conform to amendments to the FY2024 Capital Budget Ordinance, all under certain terms and conditions.

The Capital Program is the City’s six-year plan for investing in its physical and technology infrastructure, community facilities, and public buildings. The Capital Program aligns with the Mayor’s priorities and reflects the City’s and partners’ long-term commitments and plans, through efforts such as the Philadelphia2035 Comprehensive Plan, to maintain and improve public assets throughout Philadelphia. The first year of the Capital Program is the Capital Budget.

On February 27th, 2023, the City Planning Commission approved the Recommended Fiscal Year (FY) 2024-2029 Capital Program and Fiscal Year 2024 Capital Budget. The Fact Sheet Recommended Program and Budget were, as per the City Charter, subsequently submitted to the Mayor and presented by the Administration to City Council, where it was introduced on March 2nd, 2023.

On June 8th, 2023, City Council proposed and sent to the Mayor amendments to both the Recommended Program and Budget. The amendments proposed on June 8th were Recommended for Approval by the City Planning Commission on June 15th, 2023, and approved by City Council on June 22nd, 2023.

On November 2nd, the Administration worked with City Council to introduce the FY24-29 Capital Program and FY24 Capital Budget Mid-Year Transfer Ordinances, Bills 230765 and 230766. These ordinances added for FY24 \$16.130 million in CR appropriations, \$942 thousand in CA appropriations, \$30M in XN appropriations, \$665K in SB appropriations, and \$550 thousand in FB appropriations, for a total of \$48.287 million.

On November 30th, City Council introduced an additional amendment to the proposed FY24-29 Capital Program and FY24 Capital Budget Mid-Year Transfer Ordinances. This amendment added \$2.5 million in CR appropriations, bringing the new total to \$18.630 million in CR.

On March 14th, the Administration worked with City Council to introduce the FY24-29 Capital Program and FY24 Capital Budget Mid-Year Transfer Ordinances, Bills 240177 and 240178. These ordinances added, for FY24, \$105 million in CR appropriations.

“CR” Appropriations are funds transferred from the Operating Budget to the Capital Budget.

The additional \$105 million of CR appropriations are distributed as follows:

- \$45 million to Police for renovations to the Police Forensics Lab
- \$50 million to the Streets Department for streets paving, and

- \$10 million to Finance for office space renovations to Municipal Services Building and One Parkway Building.

On April 4th, City Council introduced an amendment to these Mid-Year Transfer Ordinances, Bills 240177 and 240178. This amendment added, for FY24, \$3.95 million in CN appropriations.

“CN” Appropriations are new loans financed through tax-supported general obligation bonds.

The additional \$3.95 million of CN appropriations are distributed as follows:

- \$400,000 to PPR for improvements to Vare Pool
- \$300,000 to PPR for improvements to Malcolm X Park
- \$3 million to PPR for renovations to Eastwick Recreation Center
- \$250,000 to the Streets Department for Street Lighting Improvements in Council District 10

Staff recommendation is for approval.

Questions and comments from the Commission (00:11:35).

Martine DeCamp requested for the record, that the Commission base dollar amounts of the Capital Budget and Capital Program from the screen presentation, as opposed to the written version.

Seeing no further questions and comments from the Commission or Public, Chair Mondlak asked for a motion at the minute mark in video (00:12:08).

Motion carried unanimously to approve staff recommendation for the recommended FY2024-2029 Capital Program and FY2024 Capital Budget (6-0).
