If you are unable to attend your scheduled course, you may request to attend the next scheduled course. The examination will be given at the end of the class. The test will cover information presented in the Asbestos Control Regulations, the API Manual, the class lecture, and any other information we feel you must know in order to properly perform your job as an API.

Successful completion of the course and examination are requirements for API certification. For more information on the requirements for certification, refer to the "Philadelphia Asbestos Control Regulations." Applicants who are approved for the course will receive a package of materials including an API certification application. The completed application and the required \$150.00
