# **March Meeting Minutes**

Meeting minutes from the March 18<sup>th</sup> General SWRAC meeting were approved by voice vote.

## **Organics Subcommittee Report**

Adam advised that there would be a meeting May 12<sup>th</sup> @9am to get an update on the application on Bio-solids. There is proposed ban on co-digestion is on "trucked-in waste". PADEP would prefer for high-strength wastes to be discharged into the sewer system. Notably, this means that the organic content of

the HSW will be consumed in secondary treatment, where it serves no benefit, instead of directly in anaerobic digestion, where biogas can be generated. PWD is tracking the changes and the ban on codigestion.

Temple U is wrapping up its research looking at PWD Sludge and Food waste for permit change.

## Other information

Composting project - Adam advised that the permit provisions are moving forward. Please see the link to the general Permit number with the link to the presentation (The position on Co-digestion with PWD) below.

Helena gave Office of Sustainability update, Welcoming Jocelyn NRDC regional initiative, Finalizing and testing messages, particularly around commercial disposal of organics.

# PRO update

Streets recently tested Electric trucks and have CNG trucks in the Fleet with success, though infrastructure costs have to be addressed for expansion.

TRP Study wrapped up and finding will be available by the September meeting.

Collections continues to deal with additional material at the curb with staffing challenges, however new hires are being made with some retention.

#### Open Floor

Requesting Recycling goals update by Maurice Sampson could possibly be able to start committee once everything is solidified with the streets department.

Thanks given to Neil for collecting all the data surrounding trash collection.

Logan announced that different Municipalities are suing companies that produce disposable wipes.

Discussed how plastic bags in recycling are problematic. Letters were sent to retailers asking not to promote their bags as recyclable.

Senate-break free from plastic (Senate Finance Committee) food bill.

Street Sweepers will start pilot in some areas in the fall.
