

Damage from the Roosevelt Apartment fire on July 11

You may be eligible for help.

The Pennsylvania Emergency Management Agency has made the PA Disaster Recovery Assistance Program (DRAP) available for residents recovering from the Roosevelt Apartment Complex Fire on July 11, 2024.

Those who meet DRAP grant criteria may receive a one-time grant of up to \$10,000 per household to assist with:



Temporary Housing and Rental Expenses

Covers temporary housing and rental expenses for household members and pets if you are unable to live in your home due to damage.



Essential Personal Property

Money to help replace certain essential personal property damaged by the severe storm and flooding.

If you answer "YES" to all of the questions below, you may be able to get DRAP assis	tance:

- Is your primary address 7400 Roosevelt Apartment Complex in Philadelphia, PA?
- Did you suffer damages from the fire at the Roosevelt Apartment Complex on July 11, 2024?
 - Is your household income (everyone who lives in the home) less than 500% of the national poverty guidelines? (See chart on the next page)
- Do you currently receive income-based government assistance? If not, have you applied for an SBA Disaster Loan for this event and been denied (due to an inability to repay or in adequate credit)? Deadline to apply for an SBA disaster loan is September 20, 2024.
