Bus Shelter Upgrades
Various Locations

Review Type: Encroachment located within City Right-of-Way

Project Details: Five new bus shelter installations

Applicant: Office of Transportation and Infrastructure Systems (OTIS)

Alex Smith presented three Administrative Items to the Commission beginning with the Bus Shelter Upgrades. All three Administrative Items required a consensus vote (00:04:37).

The Office of Transportation and Infrastructure Systems (OTIS), in partnership with Intersection, has submitted a series of bus shelter upgrades as part of their on-going shelter improvement program. The Art Commission typically reviews new or replacement bus shelter locations several times a year as administrative items. Today's proposal is for five new bus shelters at various locations around the city. All the locations are proposing new shelters where currently no shelter exists. Art Commission staff has reviewed each location in terms of Complete Street standards. Streets Dept has also reviewed all 5 locations. A representative from OTIS or Intersection is in attendance to answer any questions you may have.

Questions and comments from the Commission (00:06:10).

Commissioner Febo San Miguel wanted to know if the damaged sidewalk would be repaired and replaced, which Mr. Smith confirmed.

Seeing no further questions or comments from the Commission or the Public, Chairperson Roesch asked for a motion to approve (00:06:52).

Connell Park – Playground Replacement 6401 Elmwood Avenue

Review Type: Exterior site improvements

Project Details: Playground equipment replacement Applicant: Philadelphia Parks and Recreation (PPR)

Philadelphia Parks and Recreation is seeking administrative approval for a series of playground equipment replacements in lower southwest Philadelphia. The project's scope includes the removal of existing playground equipment and the installation of new playground equipment, including swings, safety surface, tables and benches all proposed within the same location as the previous playground area. The project preserves all existing trees and will maintain existing pavement in good condition.

The picnic tables are proposed around a large heritage tree but are located outside of the critical root zone area. The project budget was funded by the Council President's Office as part of the 2nd Council District. A representative from PPR is here to speak to this project and answer any questions you may have.

Questions and comments from the Commission (00:13:03).

Commissioner Almiñana wanted to know if the picnic seating was going to be placed on top of mulch around the tree or if the project team would be digging into the area to bolt them in, which Nobuki lijima, Landscape Architecture for Parks and Recreation responded, that the picnic seating will be placed on the existing concrete around the tree pit.

Parkway Central Library – Rare Books HVAC Upgrades 1901 Vine Street

Review Type: Minor construction on City property Project Details: Replacement of HVAC system

Applicant: Free Library of Philadelphia

Lastly, The Free Library of Philadelphia, Parkway Central Branch is requesting administrative approval for renovations and replacement to the third-floor rare book department's HVAC unit, located at 1901 Vine Street in Center City. The rare book department requires HVAC upgrades to provide a conservation quality interior environment to support the longevity of their collection materials housed on the third floor of the building. The current HVAC system will be replaced, and exterior equipment be located on the roof.

The height of the new equipment does not exceed the height of the existing balustrade and from the sidewalk, all equipment will be hidden from view. The Philadelphia Historical Commission has also reviewed and approved this work as the Central Library is on the local historic register. A representative is here from the design team to speak to this project and answer any questions you may have.

Seeing no further questions or comments from the Commission or the Public, Chairperson Roesch asked for a motion (00:16:01).

Matt Morong from Jacobs presented two (2) presentations for final approval and one (1) presentation for concept review, Chinatown Station beginning with, Lombard-South Station and provided an overview of the project at the minute mark in video (00:17:01).

Questions and comments from the Commission (00:27:58).

Commissioner Lowe inquired about the planter on the Broad Street Line and if they were on the property of the building owner, or if they were on the right-of-way, which would be partially city owned land. To Mr. Morong's understanding, the planter is on the building owner's property, which is part of the reason why they are working to coordinate with the building owners.

Members of the Commission and Mr. Morong continued the discussion about the planters, elevator, space on the sidewalk, overall dimensions, ADA clearances, planting areas, and the entrances to the building (00:29:34 – 00:39:32).

Chairperson Roesch stated that the consensus is to have an open space and requested that the SEPTA team continue to work with the building owner.

Seeing no further questions or comments from the Commission or the public, Chairperson Roesch asked for a motion to approve as final approval (00:39:54).

Review Type: Encroachment located within City Right-of-Way Project Details: New ADA elevator and headhouse improvements

Applicant: SEPTA Presenter: Jacobs

Mr. Morong began the second presentation Ellsworth-Federal Station for final approval, with an overview of the project at the minute mark in video (00:41:13).

Chairperson Roesch asked about the Percent for Art and requested that communication regarding purview be provided to staff (00:49:33). Additionally, there were questions about the aircraft cable, where two support columns were eliminated. Mr. Morong said that there wouldn't be an aircraft cable running under this portion of the canopy. The Chair also mentioned the unpleasant headhouse, with white grout located at Broad and Race and suggested using either grey, or a similar toned grout, which Mr. Morong agreed.

Questions and comments from the Commission (00:52:30).

Commissioner Almiñana inquired about the night view and wanted to make sure that the lighting fixtures were bi-directional that illuminate the canopy and floor; and Commissioner Osorio expressed concerns about the dimensions and exiting the elevator for commuters and ADA accessibility, particularly during rush hour, which Mr. Morong addressed and clarified.

Seeing no further questions or comments from the Commission or the public, Chairperson Roesch asked for a motion (00:57:30).

Review Type: Encroachment located within City Right-of-Way Project Details: New ADA elevator and headhouse improvements

Applicant: SEPTA

Presenter: Kelly Maiello Architects (KMA)

Victor Guarino began the presentation at the minute mark in video (00:59:07).

Chairperson Roesch asked about Percent for Art obligation, which Mr. Guarino wasn't aware of (01:06:10); however, Alex Smith stated that staff would put the applicant team from SEPTA in contact with Creative Philadelphia, because it could be based off a funding requirement and that they need to have a broader conversation (01:06:23).

Questions and comments from the Commission (01:06:51).

Commissioner Lowe recommended a before and after plan before returning for final review and asked why this location had a roll down gate, as opposed to the other two stations, then inquired about the jurisdiction and funding between the city and SEPTA regarding, One Percent for Art.

SEPTA Project Manager Sean McMahon addressed why the swing gates weren't at the street level due to the size of the canopy and how it would encroach into the street. Thus, SEPTA had to place the gate near mid-stair landing, for this station (01:09:52).

Commissioner Febo San Miguel requested a night rendering. Commissioner Nasser inquired about the stair entrances and Commissioner Lowe requested drawings of existing conditions.

Seeing no further questions or comments from the Commission or the public, Chairperson Roesch asked for a motion for conceptual approval (01:13:19).

Upon the motion made by Commissioner Nasser and seconded by Commissioner Febo San Miguel to approve for concept approval.

Chairperson Roesch complimented the building and green roof and questioned the use of the original building. Mr. Morong addressed the inquiries and added that the street level will retain the headhouse.

Commissioner Lowe suggested an interior elevation going through the turnstiles from the stairs (01:31:00). Commissioner Lowe and Chairperson Roesch asked about the lighting and for a night rendering. Commissioner Almiñana asked if there would be new paving along the street, as he didn't see the need and asked to consider using pervious paving systems, then mentioned the significant shade or spaces for seating (01:37:00). In addition, he suggested that planters would be a nice addition to the plaza space and asked about parking for bikes, considering the Indego bike station in the rendering.

Questions and comments from the Public (01:44:17).

A member of the public wanted to know how much space was between the stairs and elevator door opening. Mr. Morong said that space was at least 10 feet.

Mr. Morong addressed all comments and inquiries from the Commission and the Public.

Commissioner Lowe expressed his agreement with the public comment regarding door access for the elevator.

Seeing no further questions or comments from the Commission or the Public, Chairperson Roesch asked for a motion for conceptual approval (01:47:27).

Commissioner Segall raised concerns about the pergola, specifically about shade and the seating area and asked if there was enough room for a picnic table or other activities.

Chairperson Roesch asked if the two gates were enough to move people in and out and mentioned that the Commission hadn't really seen the project improvements for the building. Commissioner Lowe asked about the mechanical units on the roof and if there were any security grills or screens being added. Ms. To and Mr. Baier responded to the Commission.

Questions and comments from the Commission (02:26:52).

Chairperson Roesch expressed appreciation for the continued improvements for the animals and complimented how beautiful the plan and presentation were. Members of the Commission agreed. Commissioner Lowe wanted to know what kind of discussion took place regarding the design and security for the 360-trail flow of space, which was explained by Ms. Hill. Commissioner Segall inquired about what happens to the bears when their exhibit is under construction and was told that they would be moved to another zoo.

Neil Batiancila addressed comments and inquiries from the Commission (02:32:41).

Commissioner Almiñana inquired about the ribbon-cutting and suggested to embed less carbon in the design and reduce the operating carbon in the project, and perhaps look at some offsetting and amplify sequestration (02:33:49). Based on approvals, announcements will be made later in the summer (02:32:14).

They have two means of electric and all new stations do have lights, both for the canopy shelter itself, as well as the add boxes and that is done in one of two ways through solar, which is not as prevalent as running electric through the nearest street poll.
