1. Action Item: Capital Budget Bill Nos 240181 and 240182

Fiscal Year 2025 Capital Budget and Fiscal Year 2025- 2030 Capital Program Amendments. Introduced by Councilmember Gilmore Richardson on March 14, 2024. Presented by Peter Barnard.

- a. Bill No. 240181: "An Ordinance To adopt a Fiscal 2025 Capital Budget," by revising various appropriation amounts and totals, all under certain terms and conditions.
- b. Bill No. 240182: "An Ordinance To adopt a Capital Program for the Six Fiscal Years 2025-2030 Inclusive," by revising various appropriation amounts and totals to conform to amendments to the FY2025 Capital Budget Ordinance, all under certain

Background

On June 6th, City Council proposed and sent to the Mayor amendments to both the Recommended Program (Bill No. 240182) and Budget (Bill No. 230181). Per the City Charter, "Council may delete projects from the capital program as submitted to it, but it shall not otherwise amend the capital program until it has requested through the Mayor the recommendations of the City Planning Commission." The amendments proposed on June 6th would

- Increase the FY2025 appropriation under Commerce by \$2,000,000 CN for Master Planning and General Site Improvements to the Central Delaware River Waterfront.
- Appropriate a \$400,000 CN increase in Administrative and District City Council Improvement to Existing Facilities (ITEF) lines under Finance and Parks and Recreation in FY2025. This is split into an additional \$400,000 in FY2025 for Administrative ITEF, \$150,000 CN in FY2025 for each Council District under Finance, and an additional \$250,000 CN in FY2025 for each Council District under Parks and Recreation. The total increase to ITEF is \$4,400,000 for FY2025.
- Increase the FY2025 appropriation to the Free Library by \$8,500,000 CN for improvements to the McPherson Library.
- Increase the FY2025 appropriation under Parks and Recreation by \$11,350,000 CN for Buildings, Courts, Play Areas, Athletic Fields. This change will support PPR building improvement needs at the Shepard, John Anderson, Martin Luther King, Granahan, Eastwick, and Cecil B Moore Recreation Centers.
- Increase the FY2025 appropriation under Parks and Recreation by \$857,000 CN for Improvements to Neighborhood Parks. This change will support PPR improvement to Marconi Plaza.
- Increase the FY2025 appropriation under Parks and Recreation by \$2,700,000 CN for Parks and Recreation Projects. This change will support PPR improvement to Commerce Street.
- Increase the FY2025 appropriation under Streets by \$1,00,000 CN for Avenue of the Arts. This change will support greening, street furniture, and pavement improvements.
- Increase the FY2025 appropriation under Zoo by \$2,000,000 CN for Facility and Infrastructure Improvements. This change will improve City-owned facilities.
- Decrease the FY2025 appropriation under Police by \$45,000,000 (CR) for Police Forensics Facility. This funding was included in the Spring FY24-29 Mid-Year Transfer.
- Adjust carryforward (CT spending amount in Parks and Recreation for Buildings, Courts, Play Areas, Athletic Fields to reflect available appropriations.
- Adjust carryforward spending amounts in Streets for Street Lighting in CD10 to reflect available appropriations.

- Reprogram \$13,597,000 in loans authorized in previous fiscal years Prefinanced Loans (CA) to FY2025 so the funding is available for new projects. These reappropriations include:
- o \$1,365,000 (CA) for Fire
- o \$2,247,000 (CA) for Parks and Recreation
- o \$2,394,000 (CA) for Police
- o \$1,124,000 (CA) for Public Property
- o \$1,764,000 (CA) for Streets
- o \$4,703,000 (CA) for OIT

The line-item amendments for City New (CN) General-Obligation Bonds are, in order:

- Line #12 Commerce Central Delaware River Waterfront
- o Increase from \$19,800,000 CN to \$21,800,000 CN in FY2025.
- Lines #15-24 Finance Administrative and City Council ITEF CD1 10.
- o Increase from \$650,000 CN to \$800,000 CN in FY2025.
- Line #30 Free Library Improvements.
- o Increase from \$3,000,000 CN to \$11,500,000 CN in FY2025.
- Line #37 Parks and Recreation Buildings, Courts, Play Areas, Athletic Fields.
- o Increase from \$4,250,000 CN to \$15,600,000 CN in FY2025.
- Line #39 Parks and Recreation Neighborhood Parks and Facilities.
- o Increase from \$900,000 CN to \$1,757,000 CN in FY2025.
- Line #40 Parks and Recreation Natural Lands/Large Manicured Parks/Buildings.
- o Increase carryforward from \$6,550,000 CT to \$8,550,000 CT in FY2025.
- Line #41 Parks and Recreation Parks and Recreation Projects.
- o Increase from \$1,000,000 CN to \$3,700,000 CN in FY2025.
- Lines #42-51 Parks and Recreation Improvements to Existing Recreation Facilities
 CD 1-10.
- o Increase from \$950,000 CN to \$1,200,000 CN in FY2025.
- Line #66 Streets Improvements to City Highways.
- o Increase from \$2,000,000 CN to \$3,000,000 CN in FY2025.
- Line #79 Zoo Facility and Infrastructure Improvements
- o Increase from \$2,000,000 CN to \$4,000,000 CN in FY2025

Staff recommendation is for Approval.
