



Your commercial, multi-unit residential, or mixed-use property is eligible for City trash and recycling service. The fee is \$500 per year. The City of Philadelphia requires most large commercial, multi-unit residential, or mixed-use properties, to purchase private trash service. However, some smaller properties like yours are eligible to use the City service, with weekly limits on the amount of trash and recyclables left at the curb. The enclosed bill will only show your balance for 2025. If you owe past due debt on this property, you will receive a separate bill and payment voucher.

Please note, payment instructions have changed. You must pay the Commercial Trash Fee (previously the Refuse Fee), unless you already use a private hauler. Act within 60 days to avoid interest and penalties. You have three options:

Weekly Set-out Limits:

The maximum amount of non-recyclable trash allowed on the curb weekly is six, 32-gallon receptacles or 12 plastic bags, or an equivalent combination of the two. There is no limit on recyclables. If the property exceeds set out limits, the City will issue a fine.

- Pay the enclosed bill by December 31, 2024. If necessary, you can pay in two installments. The first installment of \$250 is due by December 31, 2024. The second installment is due by June 30, 2025. It is fastest to pay online at the Philadelphia Tax Center at tax-services.phila.gov. Use the "Property" panel and search by address. You do not need a username or password to pay online and you can access it from a cellphone or tablet. eCheck is always free of processing charges. You can also mail your payment using the voucher instructions.
- **Purchase private trash service.** If you use private trash service, it is fastest to visit **tax-services.phila.gov** to fill out an exemption form online. Use the "Property" panel and search by address. You will be asked to upload a photo of your current service agreement from a licensed hauler. You can also return the enclosed Exemption Form with a copy of your current service agreement by mail. Show that you have a private trash service contract in place within 60 days of the bill date or you will be responsible for the full fee.
- Qualify to receive City trash and recycling services for a waived fee. If you meet one of the criteria below, you can apply for an exemption on the Tax Center at tax-services.phila.gov. Use the "Property" panel and search by your address. Follow the prompts to upload documentation. Or fill out and return the enclosed Exemption Form by mail.
 - **Owner-Occupied Property**, the property must be 100% occupied by the owner with no tenants, residential only. Qualifying homeowners enrolled in an owner-occupied Real Estate Tax assistance program like the Homestead Exemption will be exempted automatically.
 - Owner-Occupied Duplex, the owner must live in one unit and have only one other rental unit. Qualifying
 homeowners enrolled in an owner-occupied Real Estate Tax assistance program like the Homestead
 Exemption will be exempted automatically.
 - **House of Worship**, the property must be used for religious purposes only. Qualifying properties must have their non-profit status certified by the Office of Property Assessment (OPA) to be exempted.
 - *Vacant Property*, the property must be vacant and owner must provide a current Vacant Property license from the Department of Licenses & Inspection.
