CPOC September 2024 Complaint Referral Report

In September 2024, 23 complaints of police misconduct were received by CPOC and referred to the Philadelphia Police Department (PPD) Internal Affairs Division (IAD). So far in 2024, CPOC has received and referred a total of 145 complaints to IAD.

Summaries of the 23 complaints from September 2024 are below. All demographic data is reported by complainants. These complaints only represent complaints submitted directly to CPOC and do not account for complaints filed directly with PPD.

These summaries are allegations made by complainants, they do not represent any findings or conclusions.

9/4/2024	M – B/AA	Central	The complainant called 911 after a car accident. The officer did not prepare an accurate report and was rude and dismissive to complainant's significant other.
9/5/2024	NA	South West	The complainant witnessed officers in a police vehicle using offensive language on their speaker to yell at young people walking home from school.
9/6/2024	NA	North East	The complainant called PPD to assist in receiving their child from their co-parent. The Officer who arrived on the scene was rude, gave false information regarding the situation, and did not assist in receiving the child from the co-parent.

When they asked to wait outside until the officers were ready to do the interview, the officer and supervisor did not allow this and were rude and dismissive. The supervising officer provided contact information for a children's victim specialist to complete the interview. As of reporting, the Complainant had not heard back from the contact to complete the interview.
9/11/2024	Anonymous	N/A	Officer made discriminatory remarks in social media posts on social media, violating PPD policy.
9/13/2024	F – B/AA	North West	The complainant filed a police report in order to file a private criminal complaint against another individual. The officer they filed the report with shared their personal information (address) with the individual they were filing the complaint against, leaving them feeling their safety was at risk.
9/13/2024	M – B/AA	Central	During a traffic stop, the complainant was physically dragged from their vehicle and physically assaulted. The police searched the complainant's vehicle without their consent. Complainant felt that this interaction was a result of racial profiling.
9/16/2024	F – H/L	East	The complainant made several complaints to the police about ongoing issues of drug sales on their block, but have yet to see any action taken by police.

			detective would have to set up an appointment later that day.

9/26/2024	Anonymous	South West	The complainant alleges they were improperly arrested during an illegal eviction and forcefully removed from their home by police. The complainant also says they were physically abused by police during the incident.
9/26/2024	F – N/A	South West	The complainant pulled into a gas station to make a police report after their car was side-swiped by another vehicle which left the scene. The area happened to be near a construction zone. An officer approached the vehicle and the complainant attempted to explain the situation. The officer was verbally abusive and did not assist with the hit-and-run incident.
9/27/2024	F – B/AA	North East	The complainant called 911 on two separate occasions, and no police responded. One was a noise complaint involving their neighbors. The second was to report their belligerent, intoxicated, and verbally abusive spouse.
9/30/2024	F – H/L	South	The complainant drove down a side street to get to their parking garage. While the street has a "Do Not Enter" sign, it is legal for residents to drive on to get to their garage parking. An officer questioned the complainant about whether they lived at their own home and was rude, dismissive, and unprofessional during the interaction.
