

# TARGETED BUSINESS SECURITY CAMERA PROGRAM



## ABOUT THE PROGRAM

The Targeted Business Security Camera Program provides 100 percent funding for businesses in select commercial corridors to purchase and install exterior security cameras.

**Businesses using the program must hire an approved contractor (see list below) and register their cameras with the Philadelphia Police Department.** This allows the police to contact the business to view footage in case of a crime. Registering your cameras on SafeCam takes only a few minutes and does not provide anyone with direct access to your cameras or videos.

- Photos showing where you would install the cameras
- A cost proposal from the contractor you will hire for this project
- A letter from the building owner granting permission

**Do not begin installing cameras until you receive an approval letter from the City.**
