The three **Anti-Violence Community Partnership Grants** share the unifying goal of achieving and sustaining reductions in violence, especially gun violence, in Philadelphia. The grants invest funds into organizations with a proven track record of delivering quality anti-violence interventions and diversion activities as well as individuals and nascent organizations that may not typically have access to grant funding.

GRANTS:

TARGETED COMMUNITY INVESTMENT GRANT (TCIG)

- o Awards from \$1,500 to \$50,000
- o Individuals eligible for up to \$8,000
- One-time events eligible for up to \$13,000
- o Grant Period: May 2nd September 29th, 2025
- Individuals and new programs encouraged to apply!

COMMUNITY CAPACITY GRANT (CCG)

- Awards from \$50,000 to \$100,000
- o Grant Period: March 17th December 15th, 2025
- Application by invitation to former TCIG grantees
- Grant renews for second year after one year in compliance

COMMUNITY EXPANSION GRANT (CEG)

- o Awards from \$100,000 to \$1,000,000
- o Grant Period: January 16th December 15th, 2025
- Grant renews for second year after one year in compliance

ELIGIBILITY:

- Program must take place in Philadelphia County
- Program Leader must reside in Philadelphia County
- Program must serve Philadelphia residents
- Only one application permitted per organization/event
- Applications must be submitted electronically using Submittable
- No applications will be accepted after the application closes.
- Individuals are eligible for up to \$8,000
- Applicants for \$20,000 or more must have held 501(c)(3), LLC, or B-Corp status for at least 3 years and/or be fiscally sponsored.
- City of Philadelphia employees or contractors are ineligible to receive grant funds, either directly or indirectly.

POSSIBLE PROGRAMS OR ACTIVITIES:

- Mentorship programs & activities focused on engaging youth and young adults
- Outreach events and resource fairs
- Beautification projects
- Educational events & workshops
- Activities that mobilize the community to stop gun violence

REQUIRED DOCUMENTS:

- Simple Program Budget
- Operating budgets (if applicable)
- Financial statement (if applicable)
- IRS Form 990 or equivalent
- IRS determination letter for 501(c)(3) organizations, LLCs, and B-Corps
- Bank letter confirming account with applicable tax status

AND EQUITABLY CONSIDERED.

NOTIFICATION OF AWARD DECISION.
