












Site Location

September 2021 - July 2022 – Initial Site User Surveys and Stakeholder Interviews. Feedback: Site–need for ADA accessibility and better parking/entrance; need for exercise equipment; Building–support for additional youth sports and programming, plus better restrooms in rec center building

June 2022 – Community Engagement Event #1 (pre-scope approval, to inform Conceptual Design). Feedback: Site–Need for new playground equipment, accessible pathways, field drainage, wall mural; minimal interest in tennis courts; Building–need for overall renovations

June 2023 – Community Engagement Event #2 (post-scope approval, to inform Schematic Design). Feedback: Site–Affirmed desire for swings, climbing-oriented play, and inclusive play equipment; requests for picnic tables; request for sprayground Building: Desire to have more space for programming; need for additional storage

July-November 2023 – Near Neighbor Surveys. Feedback:

Support for adult fitness equipment, seating on site; Support for swings, climbing, and slides among play options; need for improved safety on site

December 2023 – Community Engagement Event #3: (post schematic design)

Site: Articulated preferred play equipment options. Selected preferred layout for courts Building: General support for renovation plan

May 2024– Community Engagement Event #4:

Site: Articulated preferred color option








Recreation Center Plan




ENTRY FROM PARK


