Alex Smith clarified that this was initially presented at the June 26, 2024, Sign and Streetery Committee Meeting. It was referred to the full Art Commission for reconsideration at the September 11<sup>th</sup> 2024 Art Commission meeting and asked back today, October 9, 2024. Mr. Smith also clarified that no public comment took place at the June 26, 2024 SSC meeting as previously stated at the September 2024 meeting. (00:14:50)

Commissioner Osorio stated that he did not see any signage for pedestrian level. This was answered by Mr. Smith that there were previous signs that have been approved and the reconsideration was for the Building ID signage only.

Commissioner Kenyatta wanted to know why this was originally disapproved and if light pollution was considered, Elieen Quigly conveyed that this sign packaged has been studied since 2022 and the lighting limits are by right according to the zoning code.

There was additional conversation among the Commissioners about signage vs. branding and how people would identify the building by the sign.

1. 213-23 Chief Tamanend Statue - Update 1301 N Beach Street Review Type: Public Art Project Details: New bronze sculpture of Chief Tamanend Applicant: Creative Philadelphia

Alex Smith began the administrative agenda for the meeting and introduced Margurite Anglin of Creative Philadelphia (00:34:28)

Creative Philadelphia (formerly known as the Office of Arts, Culture and the Creative Economy) is requesting administrative approval for the updates to the Chief Tamanend statue proposed to be installed at Penn Treaty Park at 1301 N Beach Street. This public art sculpture is proposed by the Chief Tamanend at Penn Treat Park Committee and is to be donated to the City of Philadelphia's permanent public art collection.

Several modifications to the statues design have been made by the artist at the guidance of the Federal Tribes. These changes more accurately represent Chief Tamanend and the Lenape Community and were approved by various stakeholder groups.

The updates include changes to the following:

- □ **Physique:** The design has been revised to show less muscle definition reflecting a more realistic representation of Chief Tamanend.
- □ **Clothing:** The design has been revised to provide more rear coverage at the breechcloth Chief Tamanend is wearing.
- □ **Headdress:** The headdress has been removed, in response to a concern that the provision of a headdress may not be historically accurate.

- □ **Necklace:** The original design showed Chief Tamanend wearing 2 necklaces,
  - 1) a symbolic turtle shaped necklace stylistically referencing Tamanend's connection to the Turtle clan.
  - 2) a necklace pouch. The artist removed the necklace pouch from the revised design and revised the turtle necklace to be an outline of a turtle instead of a turtle shell at the Federal Tribes recommendation.
- □ **Leggings:** The leggings have been changed to mid-thigh height which is more accurate for Lenape men of Tamanend's age and finally,
- □ **Hairstyle:** Chief Tamanend's hairstyle has been updated to reflect the hairstyle typically worn by Lenape men.

Questions and comments from the Commission (00:41:34).

Commissioner Febo San Miguel stated that she appreciates the effort to be historically accurate.

Commissioner Lowe had a questioned if the feathers in the hair were agreed upon by the federal tribes. Marguerite answered yes, they were agreed upon.

There was future discussion about signage and the location of statue in the park. Commissioner Kenyatta had remarks about the non-opposition letter that was provided by the Friends of Penn Treat Park (00:46:00).

Commission Osorio asked if there are any plans for lighting. Marguerite answered that Parks and Recreation will be providing the lighting.

Seeing no questions or comments from the Commission or the Public, Chairperson Roesch asked for a motion to approve (00:52:38).

The vote was taken by consensus.

Bicycle Transit Systems (BTS) on behalf of the Indego and the Office of Transportation and Infrastructure Systems is seeking administrative approval for five new IKE Smart City kiosks at the intersections of:

For each location, the kiosk location is also being reviewed by the Streets Department for compliance with Complete Street and dimensional standards. Additional information has been provided by the applicant team regarding ridership info based on previous requests from the Commission.

Alex Smith summarized the third administrative agenda item (00:54:55)

The Office of Transportation and Infrastructure Systems (OTIS), in partnership with Intersection, has submitted a series of bus shelter upgrades as part of their on-going shelter improvement program. The Art Commission typically reviews new or replacement bus shelter locations several times a year as administrative items. Today's proposal is for eight new bus shelters at various locations around the city. These are the original bus shelter series, not the recently approved narrow shelters. All the locations are proposing new shelters where currently no shelter exists. For each location, the shelter's location is also being reviewed by the Streets Department for compliance with Complete Street and dimensional standards. Review Type: Construction project on City Property Project Details: Restoration and rehabilitation of exterior facade Applicant: Department of Public Property (DPP)

The Department of Public Property, with consultants DIGroup Architecture, are seeking administrative approval for façade restoration work to MBS at 1401 JFK Blvd.

The project originated with a 2021 façade inspection, which noted several deficiencies and unsafe conditions including cracked granite panels, deteriorated sealants, deteriorated window gaskets and cracked windows. The proposed scope of work will include the restoration or replacement of granite faced precast panels to be secured with the installation of new anchors, joints to be raked and re-sealed with new sealant for both the granite faced panels and windows and other restoration and cleaning work where necessary.

Commissioner Febo San Miguel requested further clarification on the need for two curb cuts.

Commissioner Lowe suggested possibly raising the curb cuts to sidewalk level for priority of pedestrians. Daniel Lyons noted that they can raise the curb cut sidewalk.
