

Key Crash Trends



High concentration of **pedestrians** and motorcyclists in severe cases (17/23)



Higher than city average red-light running rate



Large number of angled and leftturn crashes (> 28%)



Pedestrian crashes most often occurred at 3 – 9 PM










Proposed Design

Possible Extension to Lehigh Avenue

- If funding is available
- Similar to the design between Allegheny and Westmoreland



Possible extension area



Allegheny to Westmoreland

Parking is not affected

Speed cushions

Raised crosswalks on side streets

Widened sidewalk

Repaved street and sidewalk

Bike lanes will be raised to the sidewalk level
