

My name is Monica Gonzalez, I am a resident of West Mt Airy and a member of West Mt Airy Neighbors, and I would like to express my personal support for the nomination of these apartment buildings to the Philadelphia Register of Historic Places as a Thematic District.

I live behind three of the apartment buildings in the nomination: Pelham Court #1 and #2, and Emlen Arms. The Pelham Court apartments and Emlen Arms are quite different from each other architecturally, and that exemplifies the variety of apartment styles that were getting built in the early 20th century.

Despite their aesthetic differences, these three apartments highlight the changes in the neighborhood brought about by the extended railway line. Apartments as tall as Emlen Arms at 9 stories had a place here by the mid-1920s, a scale and a density supported by the nearby Carpenter Lane train station.

It is important to preserve the transit-oriented development highlighted in this nomination and acknowledge their continued role in providing well-connected housing to this day.

Dear Chairman Frankel,

I am writing to express my strong opposition to the inclusion of Sedgwick Gardens, located at 6907 McCallum Street, in the proposed Northwest Philadelphia Apartments Thematic Historic District. I fully support the position of the property owner, Lindy Communities, and their request to remove Sedgwick Gardens from the inventory of the proposed district. Additionally, I support Lindy's request for a brief continuance of the Historical Commission's consideration of the district to allow them adequate time to prepare and present their case.

It would be inappropriate for the Historical Commission to exercise greater authority than the Lindy family over the future of Sedgwick Gardens. The Lindy family's connection to the property is deeply personal and foundational to their legacy. Built by Jacob Lindy in 1939, Sedgwick Gardens has been lovingly maintained by the family for over 85 years. Their exemplary stewardship of the property speaks volumes about their commitment to its care and preservation. Imposing the oversight of the Historical Commission would create unnecessary administrative burdens, requiring approvals for even minor changes such as window replacements, landscaping updates, or green initiatives. Such oversight could hinder the Lindy family's ability to adapt and enhance the property in alignment with their vision.

Moreover, the Lindy family has made extraordinary contributions to the City of Philadelphia through their public service and philanthropy. Their initiatives include the Legacy Youth Tennis and Education Center, ASAP (After School Activities Partnerships), Fiesta Schoolyard, the Lindy Scholars Program, the Philadelphia Mural Arts Program, the National Liberty Museum, Jefferson Philadelphia Collaborative for Health Equity, Drexel Lindy Center, Drexel Lindy Institute, and the Lindy Resident Emergency Rent Relief Fund. Considering all that the Lindy family has given to the city, it would be unjust to strip them of their autonomy over a property so deeply intertwined with their history and legacy.

Thank you for considering my position on this matter. I urge the Historical Commission to respect the Lindy family's stewardship of Sedgwick Gardens and their request to retain control over this cherished property.
