Re: 7801 State Road-- Riverview Wellness Village, Proposed New Building

Dear Art Commissioners and Art Commission Staff,

This letter is written on behalf of the Managing Director's Office (MDO), and the Capital Program Office (CPO), of the City of Philadelphia, regarding the proposed new 5-story building at the existing Riverview Wellness Village complex. Please consider this as our formal request to be placed on the agenda of the February 12, 2025 Art Commission meeting.

The Riverview Wellness Village ("RWV" or "Riverview") is an existing campus of approximately 19 acres located at 7801 State Road. Originally constructed in 1956 as an indigent housing complex and later as an elderly care home, the current function of the campus is as a wellness care and recovery housing center. RWV is a critical component of a broader City-wide wellness ecosystem in place to serve residents struggling with drug addiction, mental health challenges, and/or homelessness. Presently, there are numerous existing buildings on the campus, consisting of six (6) residential cottages and a communal Meeting House building, which also includes a communal dining area. These existing buildings are interconnected by a series of interior solariums, with the exception of the "Fernwood" cottages. The RWV site is accessed by a vehicular path off of State Road and is adjacent to the Pennypack on the Delaware public park. Within its fenced perimeter is a loop road, distributed parking, various landscaped areas, and a maintenance service building.

The project for a proposed new 5-story building on the campus is intended to expand capacity by approximately 300 residential beds, along with additional clinical care support functions. The proposed building is in the location of a former residential cottage (Elm Cottage) which was demolished in 2019, and will be connected to the rest of the complex by one of the existing solariums. Residential program in the new building will include double occupancy dormitory-style rooms with shared bathrooms at lower levels, as well as efficiency apartment-style studio units at upper levels. Support program will include common residential kitchen and lounge spaces, as well as support and office function for an on-site care provider. This new building will be funded by City of Philadelphia capital funds, with a budget of approximately \$50M.

The construction of this new building is intended to address a critical gap in Philadelphia's wellness ecosystem by addressing a shortage in recovery-focused housing. The site's setting along the Delaware River provides the campus with a unique and tranquil environment which is supportive of the type of care it offers, and this new building is designed to take advantage of these positive aspects to enhance the experience of its residents on their road to recovery. We look forward to sharing greater detail on this important project with you in our submission package next week, as well as to receiving the valuable feedback that the Art Commission will offer in its review of the project.

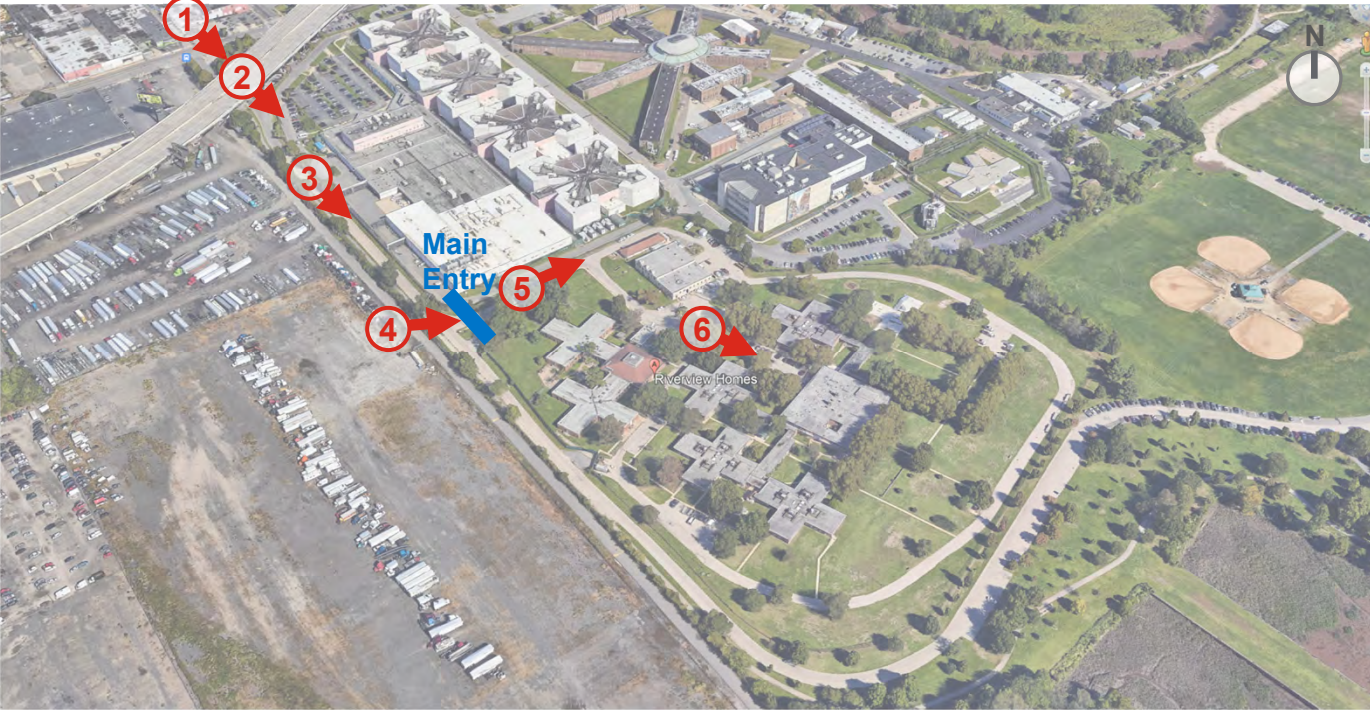

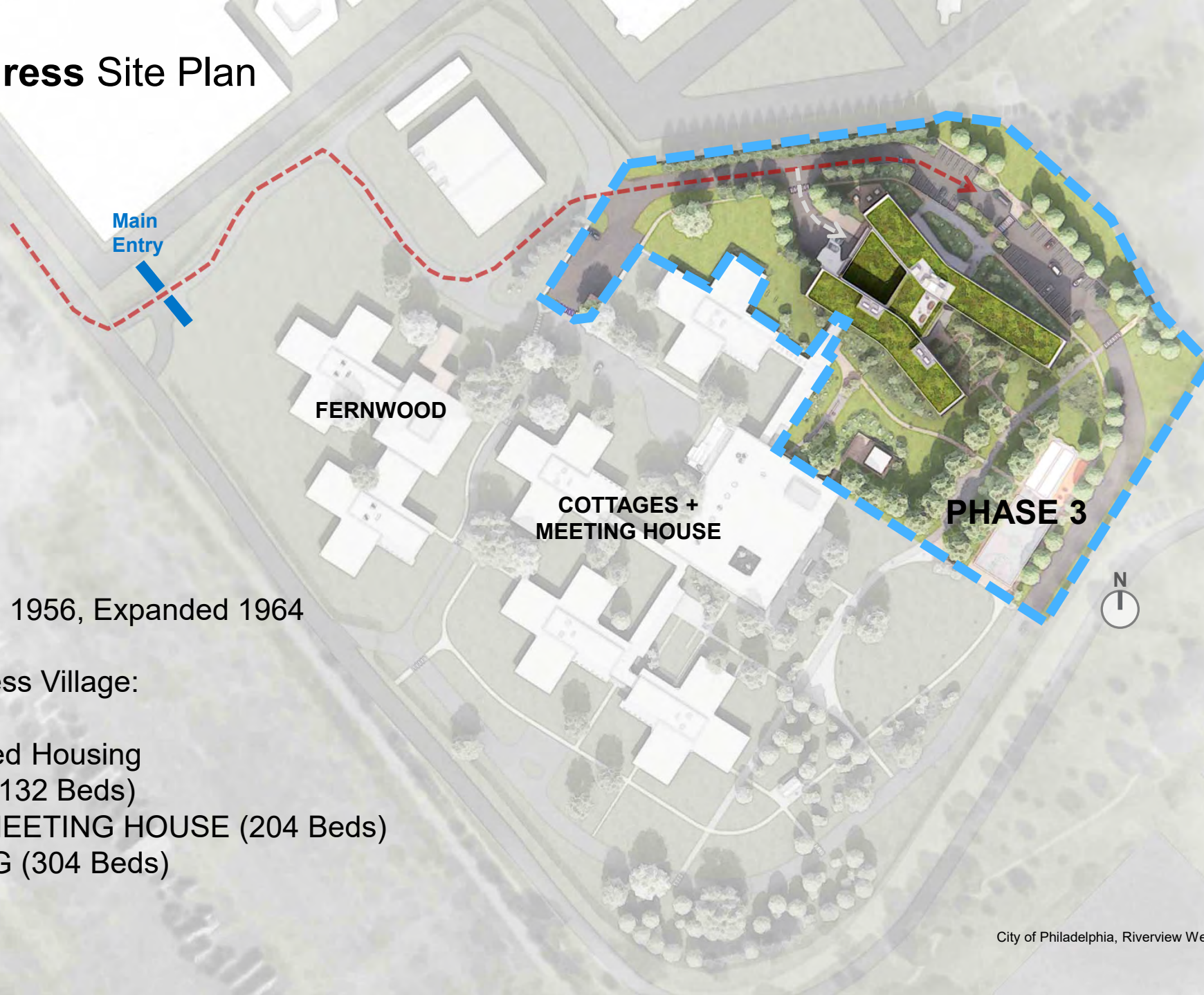

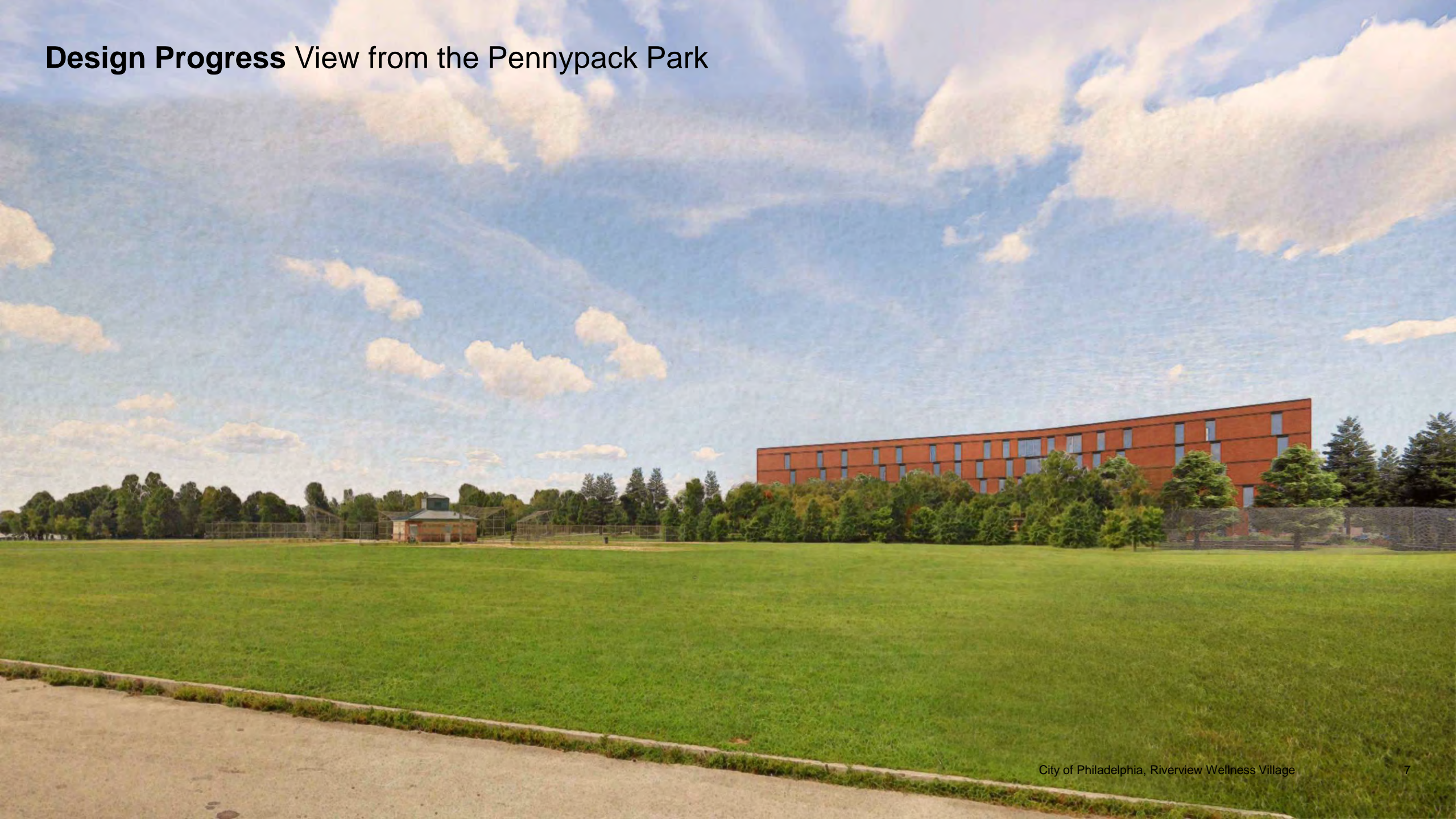

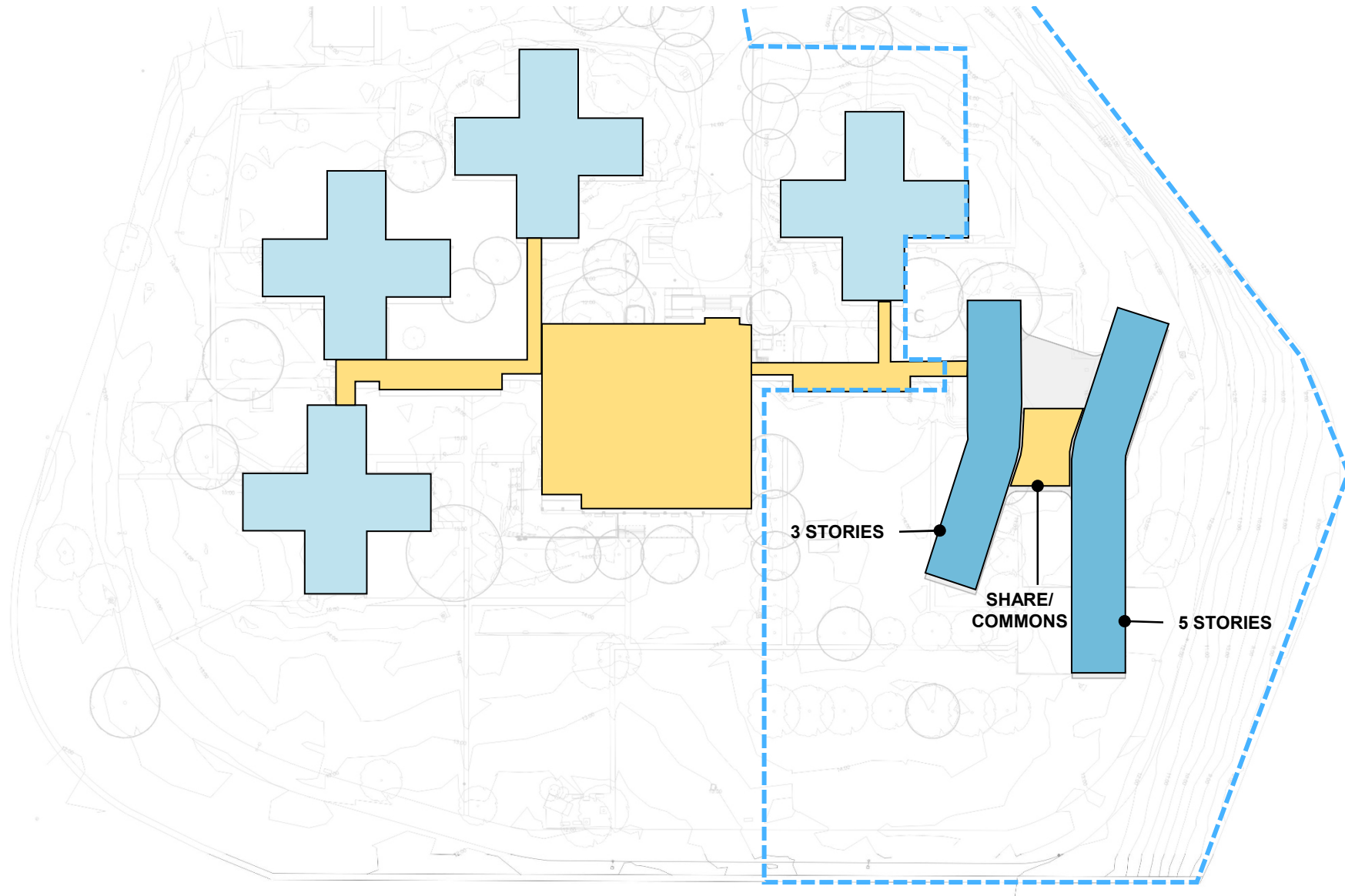

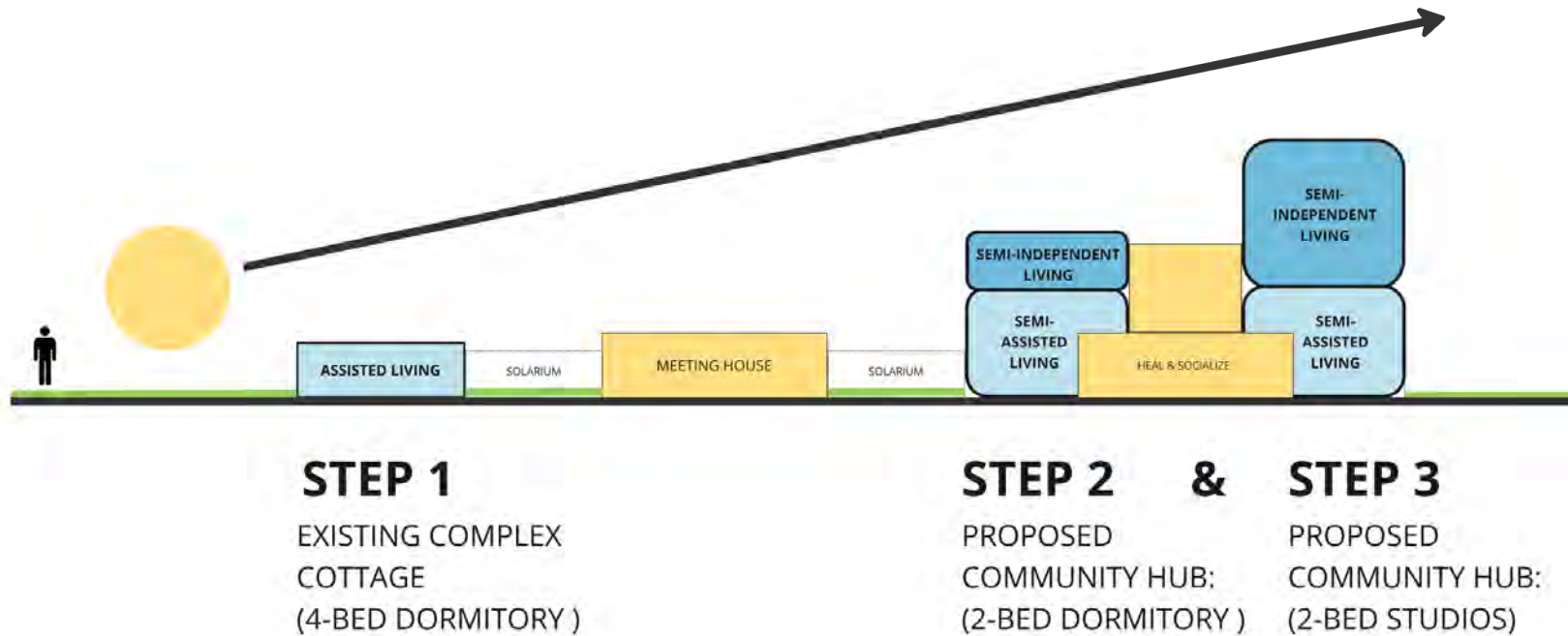

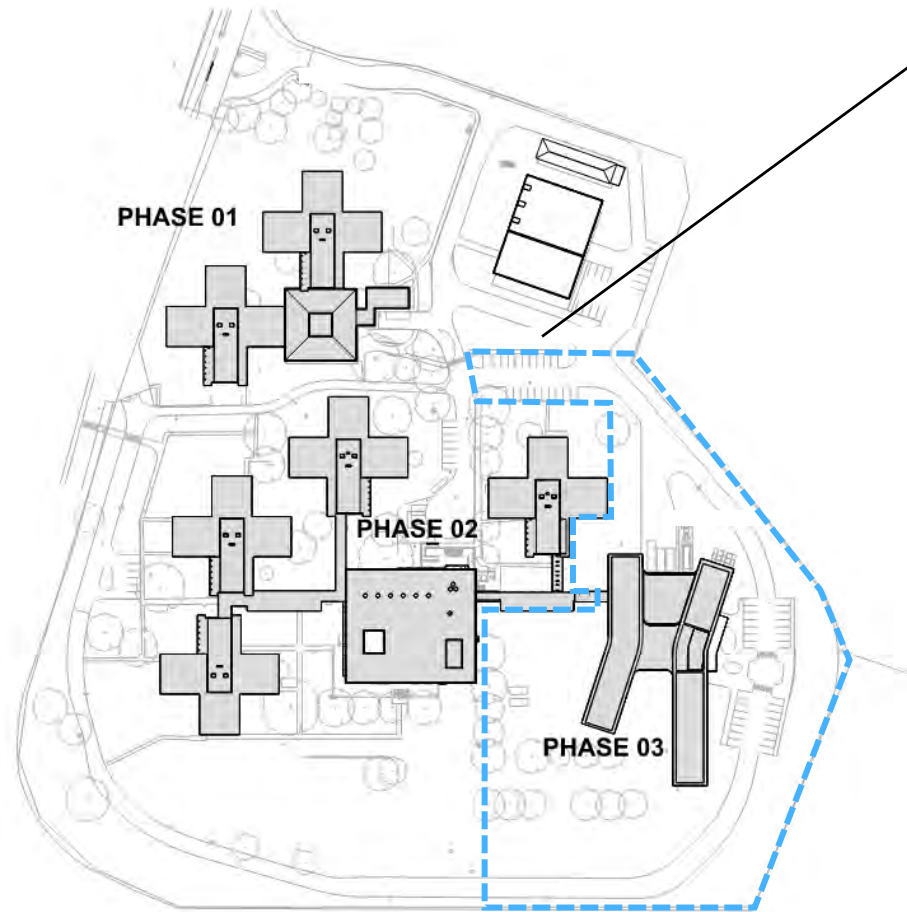

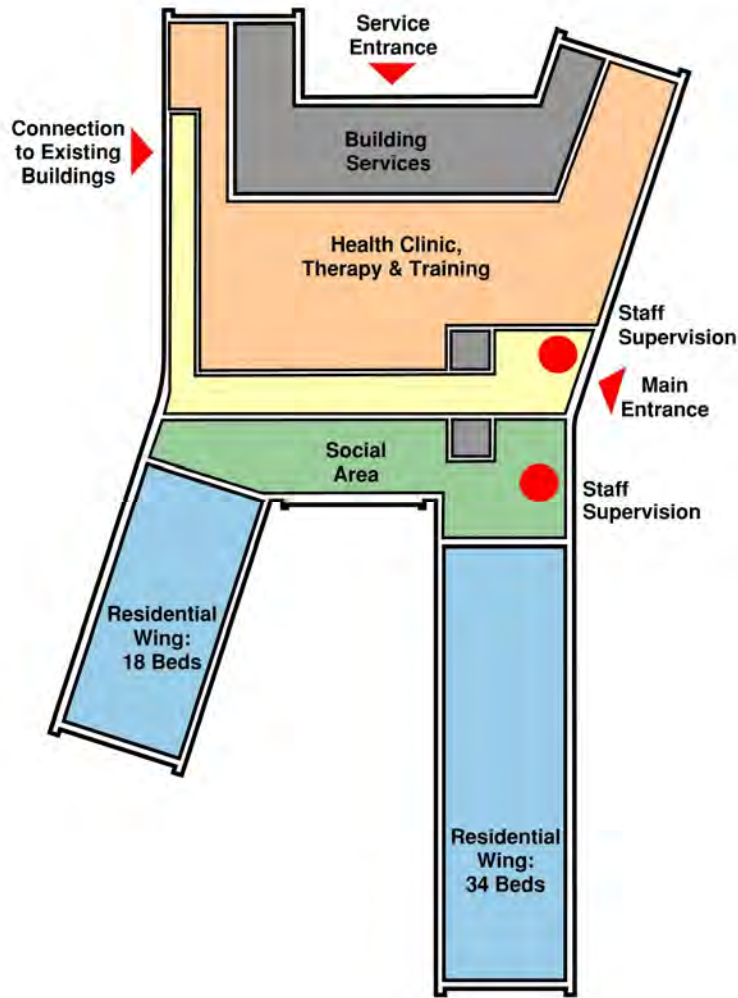

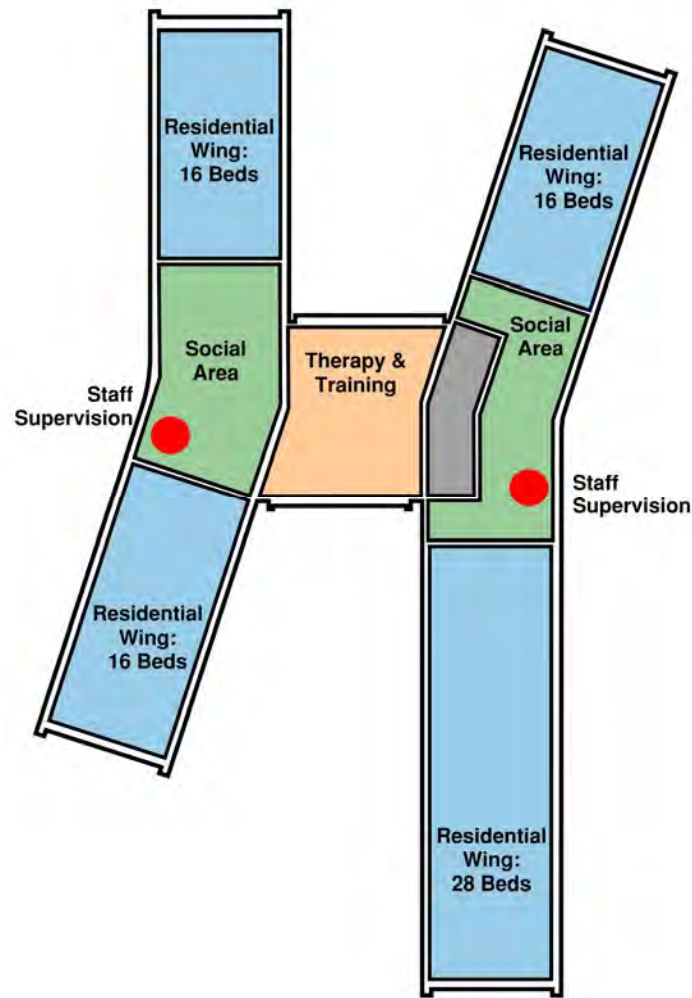

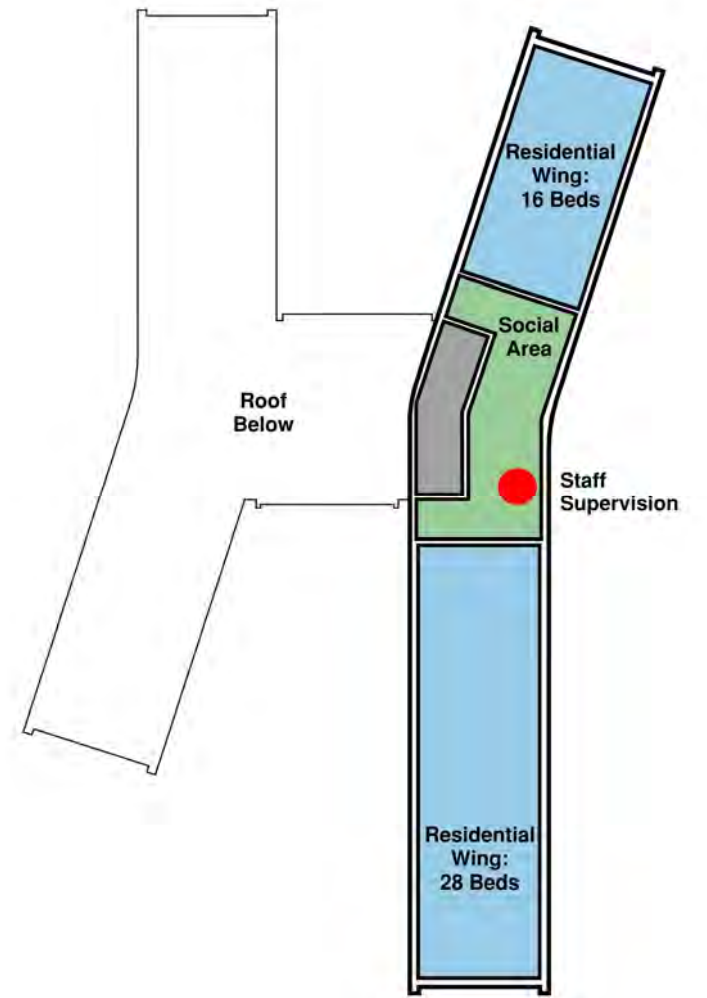

MATURE CANOPY



The site has mature mid-century canopy trees to remain which will be protected and preserved. The project will fill gaps in the canopy while establishing diverse habitats across the site.
