—Are you listening?

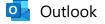

Hello,

As a member of the Philadelphia community it saddens me to see the initial approval of this stadium. As an engineer myself all I want to do is help brighter and improve a community. To help the community unite and be proud of where they live. You know that development is the way of life, but to enrich, not to make the rich richer.

This stadium is in a historically significant area and the displacement of the Chinatown community. The neighborhood is home to many low-income residents, small businesses, and cultural institutions. If the new stadium were to be built, it could spur gentrification, pushing out long-standing residents and businesses due to rising rents and property values. This could lead to the loss of cultural heritage and a shift in the demographic makeup of the area, further exacerbating housing affordability issues in the city.

Chinatown is located in an area already facing environmental burdens, such as air and noise pollution from nearby roads and industrial zones. The addition of a large sports stadium could worsen these conditions. With expected increases in traffic, particularly on game days, air quality could deteriorate, and noise pollution could disturb both residents and local wildlife. Furthermore, stadiums tend to consume significant energy and water, which could contribute to the city's overall health.

While the arena's developers argue that the stadium would be well-served by public transportation (such as SEPTA rail lines and buses), the influx of thousands of fans could increase traffic congestion around the area. This may result in higher carbon emissions due to more cars on the road, which could further strain the already crowded streets and exacerbate pollution levels. The added strain on infrastructure might also lead to more frequent road maintenance, adding to the environmental cost over time.
