SUBJECT: Request for Art Commission Administrative Review of Public Art Conservation

Dear Alex and Katherine,

Creative Philadelphia is submitting this letter to the Art Commission for Administrative approval of conservation work for the following City of Philadelphia owned public art sculptures to take place during 2024-2025. Note that items 19-21, identified by asterisk (*), required emergency or timesensitive conservation work that is either in process or completed, and are included in this letter for record/notification.

The conservation scope of work for #1, *Untitled (Cubes and Triangles)* includes cleaning the sculpture to remove soiling and spot patinating the sculpture. Conservation treatments will be performed by Heritage Conservation Collective, LLC.

For #2, *Harrowgate Park Memorial*, the conservation work consists of cleaning the masonry, cleaning and waxing the bronze eagle sculpture, removing the chipping paint on the front of the granite base, and pointing mortar joints. Treatments will be performed by Heritage Conservation Collective, LLC.

For #3, *The Bones*, the treatments consist of cleaning and reattaching loose bricks on the base and cleaning and waxing the bronze. The conservation work will be performed by Heritage Conservation Collective, LLC.

For #4, Sky Beast, the work consists of scraping chipping paint off the base, performing composite repairs to the missing components on the sculpture, and painting the sculpture and base to match the existing color. The work will be performed by Heritage Conservation Collective, LLC.

For #5, Fire Engine, the conservation treatments consist of cleaning and waxing the bronze relief. The work will be performed by Heritage Conservation Collective, LLC.

For #6, *Orball*, the work consists of removing the existing failing paint system, priming the sculpture with a rust inhibiting primer and painting the sculpture with a paint system that matches the original color. The work will be performed by Heritage Conservation Collective, LLC.

For #7, Word Play, the work consists of removing graffiti from the sculpture, scraping loose paint, and painting the sculpture to match the existing color. The work will be performed by Heritage Conservation Collective, LLC.

For #8, *Unknown* by Stewart Zane Paul, the conservation treatments consist of repairing the missing seat component and refinishing the table and seat tops. The work will be performed by Heritage Conservation Collective, LLC.

For #9, *Civil War Soldiers' and Sailors' Monument*, conservation treatments consist of repointing joints on the steps of the monument, clearing invasive vegetation, and cleaning and waxing the bronze elements. The work will be performed by Heritage Conservation Collective, LLC.

For #10, *Three Bears*, the work consists of cleaning the stone bears and the base to remove soiling and biological growth. The work will be performed by Heritage Conservation Collective, LLC.

For #11, *Tablet for the Battle of Germantown*, the work consists of cleaning and waxing the bronze plaque and letters, and cleaning and filling in cracks in the cast stone around the plaque. The conservation treatments will be performed by Heritage Conservation Collective, LLC.

For #12, *Memorial Stone for Womrath Park*, conservation treatments include fabricating and installing a new plaque that replicates the missing original plaque and cleaning the stone base. The work will be performed by Heritage Conservation Collective, LLC.

For #13, School Is Out, the work consists of making composite repairs where the backerboard is exposed and cleaning the blackboard surface to remove soiling. The work will be performed by Heritage Conservation Collective, LLC.

For #14, *Henry Howard Houston Memorial*, conservation treatments include cleaning the monument base, stone benches, the pebble floor around the monument, and repointing all joints. The work will be performed by Heritage Conservation Collective, LLC.

For #15, *The Octavius V. Catto Memorial*, the work consists of cleaning and waxing the bronze sculpture and plaques, cleaning the stone components, and replacing the missing letters on the base. The work is being performed by Kreilick Conservation, LLC.

For #16, Charting a Path to Resistance, the conservation treatments consist of reattaching fully and partially detached wallpaper panels. The work will be performed by Studio Ranalli.

For #17, *Triune*, the conservation treatments consist of repairing the masonry base, and cleaning and waxing the bronze sculpture. The work will be performed by Kreilick Conservation, LLC.

For #18, *Leviathan*, the conservation treatments consist of stabilizing the sculpture by fabricating a thicker, stronger base to form around the original base, which will be bolted to the stone to prevent any damage from wind or vandalism attempts. The work will be performed by Kreilick Conservation, LLC.

For #19, LOVE, the work consisted of cleaning streaking on the front of the sculpture, applying a protective wax, and replacing a missing bolt that attaches the sculpture to the base. Due to the emergency nature of this work, the conservation treatments were performed and completed by Heritage Conservation Collective, LLC and this letter serves as a notice to the Art Commission for record.

For #20, John Wanamaker, conservation treatments consisted of cleaning graffiti off the base of the statue. Due to the emergency nature of this work, the conservation treatments were performed and completed by Kreilick Conservation, LLC and this letter serves as a notice to the Art Commission for record.

For #21, Joan of Arc, conservation treatments consisted of removing a flagpole that was duct taped to the sculpture and removing the adhesive residue on the statue. Due to the emergency nature of this work, conservation treatments were performed and completed by Heritage Conservation Collective, LLC and this letter serves as a notice to the Art Commission for record.

We are requesting for this to be included on the **March 12**, **2025** Philadelphia Art Commission meeting agenda as an Administrative item for approval (as typically presented in the past).
