Re: Formal Notice of Proposed Changes in Water, Sewer and Stormwater Rates and Related Charges (FY 2026 and FY 2027)

The aforesaid filing will also be made available at the Rate Board's website: https://www.phila.gov/departments/water-sewer-storm-water-rate-board/rate-proceedings/. Once the rate filing is available on the Rate Board's website, the Dropbox website will not be needed and will expire.

The Formal Notice filing includes the proposed rates and charges, which are subject to review and authorization by the Rate Board. The Board will schedule public hearings on the proposed rates and charges, as required by Section 13-101(3)(f) of the Code.

The proposed rates and charges are set forth in PWD Exhibit 3A through 3D of the rate filing. These proposed rates and charges will be fully vetted as part of the rate process before the Rate Board.

This submission is the Formal Notice required to be filed with the Department of Records pursuant to Section 13-101 (7)-(8) of the Code and Section II.A.2(b) of the Rate Board's regulations. Included with this submission are various statements and exhibits from the Advance Notice (identified in the attached Filing Index) that will be proffered for inclusion in the record during hearings before the Rate Board. Also attached is the Statement of Changes from the Advance Notice filed with City Council and the Rate Board on February 18, 2025, as well as copies of the changed documents identified therein. Finally, attached please find the memorandum from the Law Department approving this Formal Notice and the accompanying documents as to form.

Please make the above documentation, together with the Department's proposed changes in rates and charges, available for inspection consistent with the aforesaid legal requirements and arrange for advertising in accordance with Section 8-407 of the Charter and Section 21-1703 of the Code. STATEMENT OF CHANGES FROM THE ADVANCE NOTICE FILED WITH CITY COUNCIL AND THE WATER, SEWER AND STORMWATER RATE BOARD

Pursuant to Section II.A.2(b) of the Regulations of the Philadelphia Water, Sewer and Storm Water Rate Board ("Rate Board"), this statement highlights changes from the Advance Notice of proposed changes in rates and charges filed by the Philadelphia Water Department ("Department" or "PWD") with City Council and the Rate Board on February 18, 2025. The changes and the rationale for the changes are provided below:

Please take note that the following changes were made prior to Formal Notice:

- **PWD Statement 1:** A typographical error was corrected on page 6. The error was in the the amount of the additional incremental revenues in FY 2026.
- **PWD Statement 4A, Schedule BR-1:** The resume of Brenden Reilly from February 2025 is being deleted and replaced in its entirety with the resume of March 2025 to reflect his new position and responsibilities.
- **PWD Statement 5, Schedule SMC-2:** The proposed charity rate regulations from February 2025 are being deleted and replaced in their entirety with the proposed charity rate regulations of March 2025 to reflect style and other changes.
- PWD Statement 7, Appendix A: Appendix A (February 2025) consists of one table showing: "Number of Accounts and Account Growth." Appendix A is being supplemented to add a second table showing: "Annual Billed Volume Per Account"
- **PWD Statement 7, Appendix H, Table 1:** The prior Table 1 in Appendix H is being deleted in their entirety. Appendix H Table 1 (March 2025) replaces the prior Appendix H Table 1.
- **PWD Exhibit 6**: Black & Veatch work papers (calculations supporting Schedules BV-1 and BV-2) were provided for PWD Exhibit 6. The original PWD Exhibit 6 was marked "To be provided".
